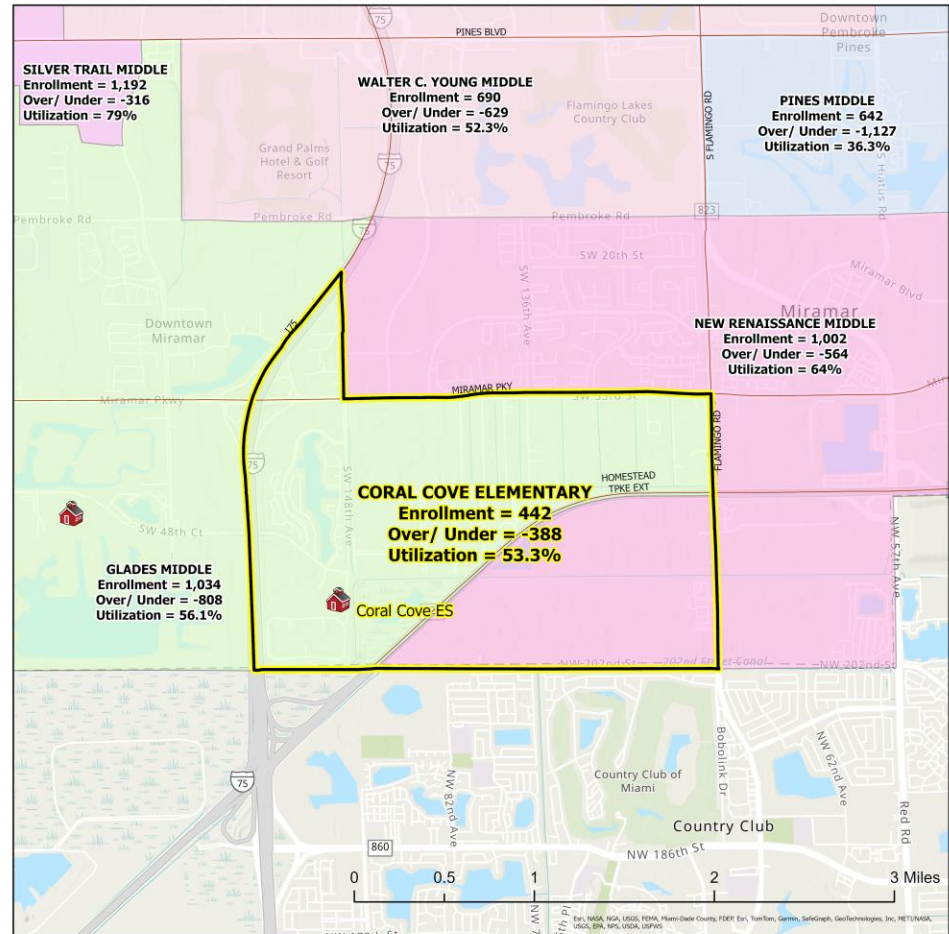
For tonight's discussion we'll be talking about the following schools:

- **Coral Cove Elementary:** Reconfigure as K-8
- **Silver Lakes Elementary, Silver Shores Elementary, and Silver Palms Elementary:** Consolidate Silver Shores into Silver Lakes and Silver Palms; create full choice K-5 or K-8 in Silver Shores
- **Hollywood Central Elementary:** Reconfigure as K-8
- **Pines Middle:** Reconfigure as 6-12

Coral Cove Elementary Potential K-8 Reconfiguration

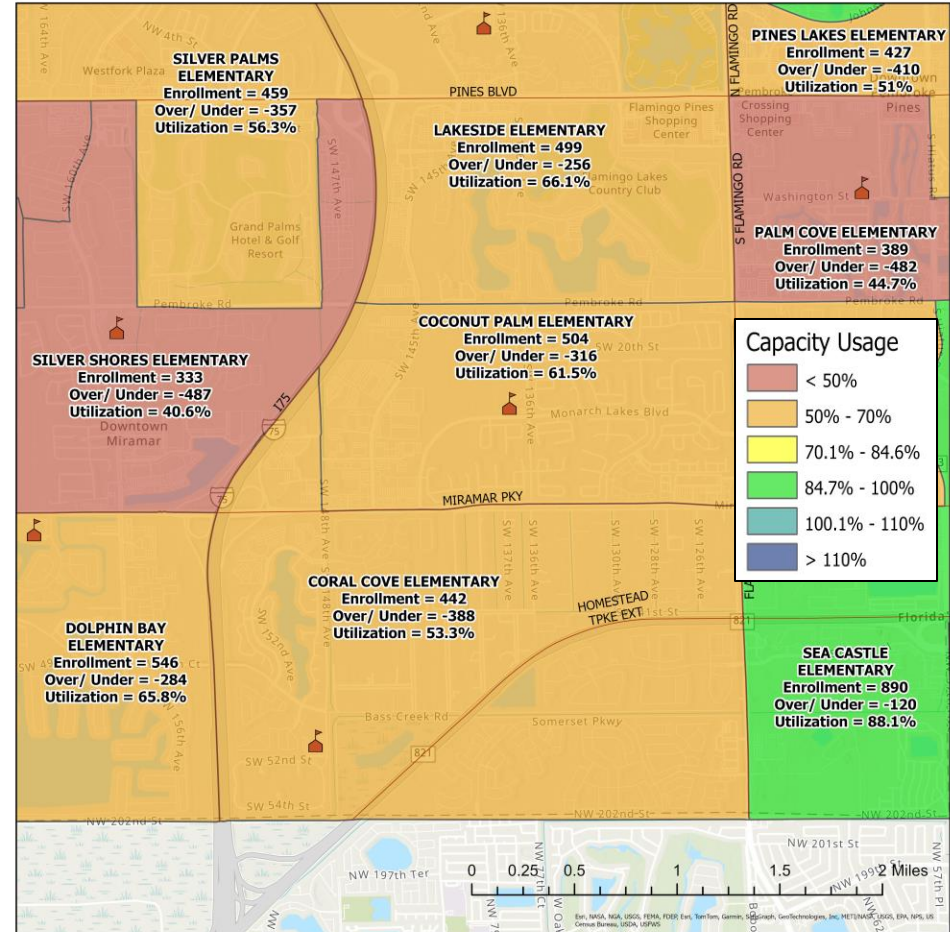
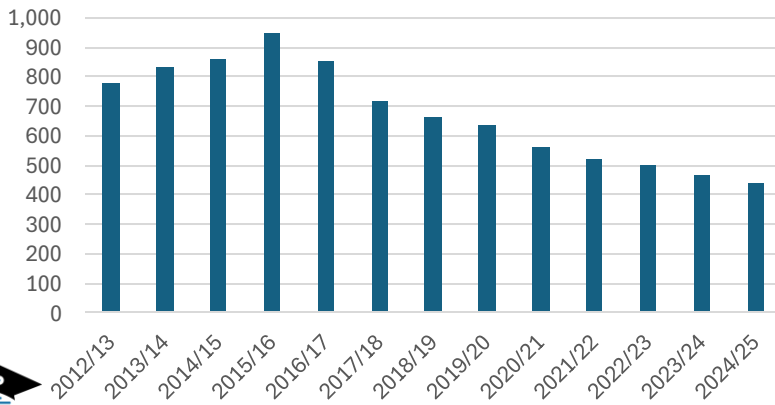
- Reconfigure Coral Cove Elementary as a K-8 school
- Currently 511 6th-8th grade public school (BCPS + charter) students living in Coral Cove ES boundary
 - 118 (23.1%) attend their assigned middle school
 - 68 attend Glades Middle
 - 50 attend New Renaissance Middle
 - 299 (58.6%) attend charter schools



Coral Cove Elementary Enrollment and Capacity Usage

- Total Students Living In Boundary = 836
- In-Boundary Students Attending = 371
- Percent of Assigned Students Attending = 44.4%
- Out-of-Boundary Students = 71
- ESE Classes = 3
- Prekindergarten Classes = 1

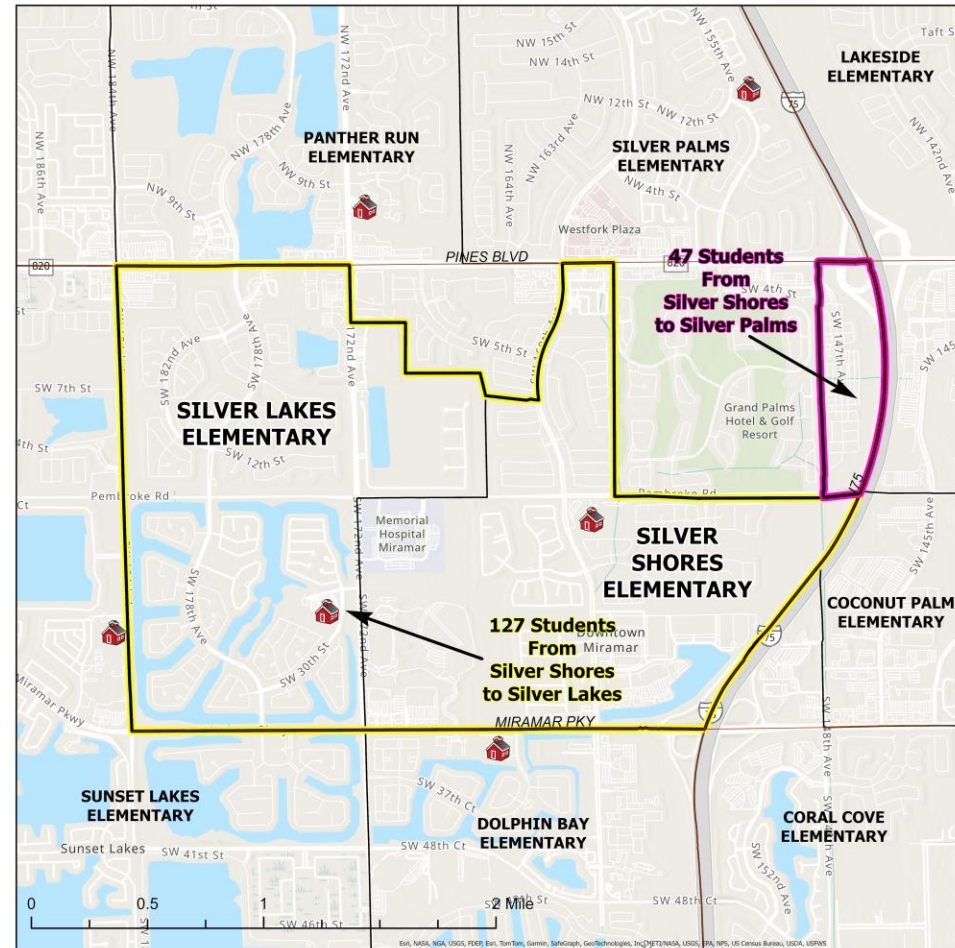


Coral Cove Boundary Considerations

Consideration	
Impact on Enrollment	Coral Cove Elementary current enrollment= 442 students/ 53.3% capacity usage; proposal would result increase enrollment by adding three grade levels
Impact on Feeder Patterns	No impact; middle school enrollment is a choice option
Impact on Neighborhood Integrity	Improves neighborhood integrity by allowing students to remain in their community from through 8 th grade
Impact on Distance to School	Improves distance to school for 6 th – 8 th grade students who currently have to travel to either Glades Middle or New Renaissance Middle
Impact on School Diversity	Is not anticipated to impact diversity as 6 th - 8th grade students will matriculate from elementary grades at Coral Cove Elementary
Impact on Students with Special Needs	Coral Cove Elementary: 93 ESE students/ 4 ESE special programs

Consolidate Silver Shores into Silver Lakes and Silver Palms

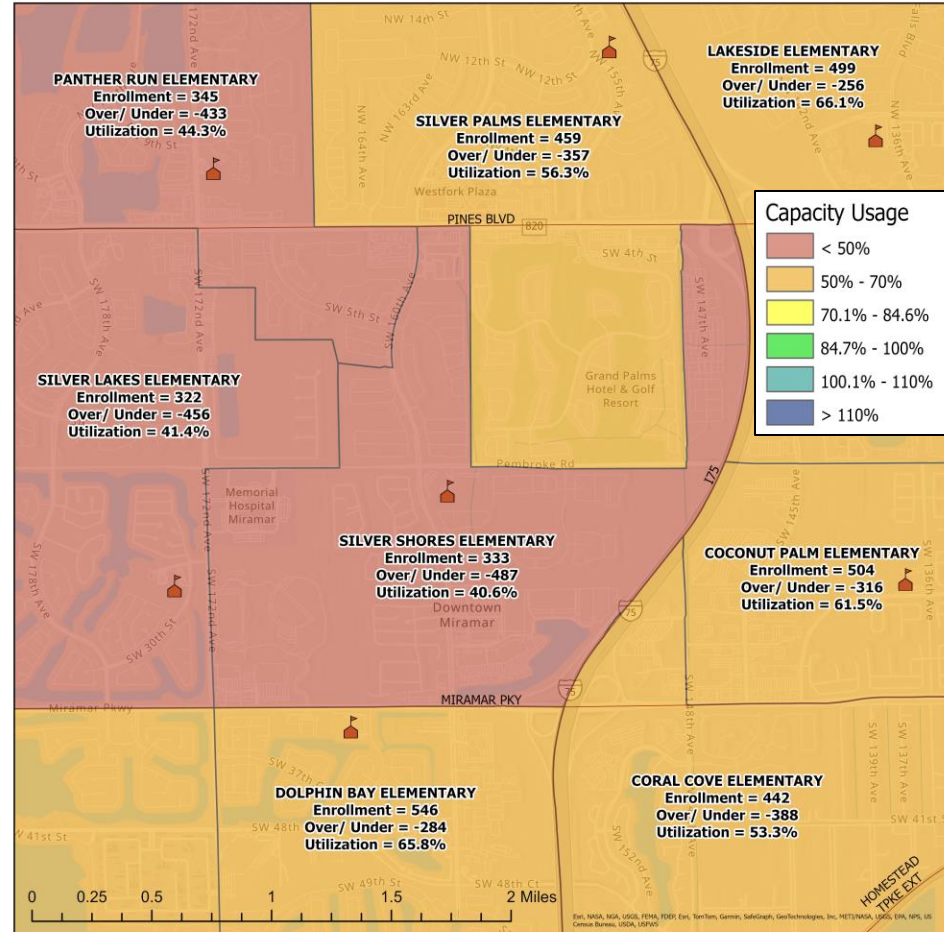
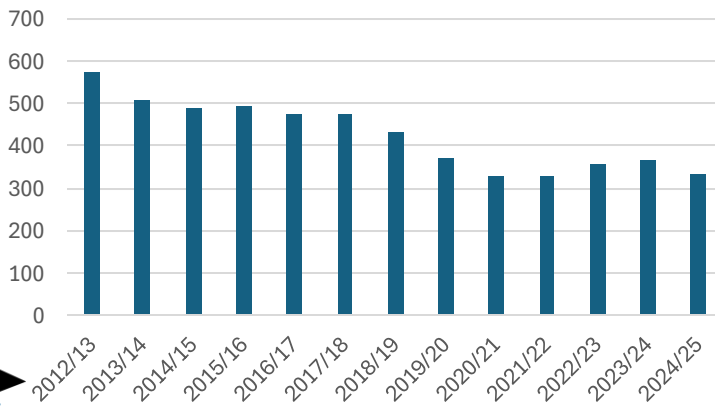
- Combine Silver Lakes Elementary and Silver Shores Elementary so that all in-boundary students attend Silver Lakes Elementary
- Move the portion of the current Silver Shores Elementary north of Pembroke Road into Silver Palms Elementary
- Create a full choice K-5 or K-8 School at Silver Shores Elementary with a specialized theme of study based on community input
- Reserve a defined number of choice seats for students who reside in the current Silver Shores Elementary boundary
- Consider availability of space to maintain current programs for students with special needs at all three schools

- Total Students Living In Boundary = 525
- In-Boundary Students Attending = 174
- Percent of Assigned Students Attending = 33.1%
- Out-of-Boundary Students = 159
- ESE Classes = 12
- Prekindergarten Classes = 0

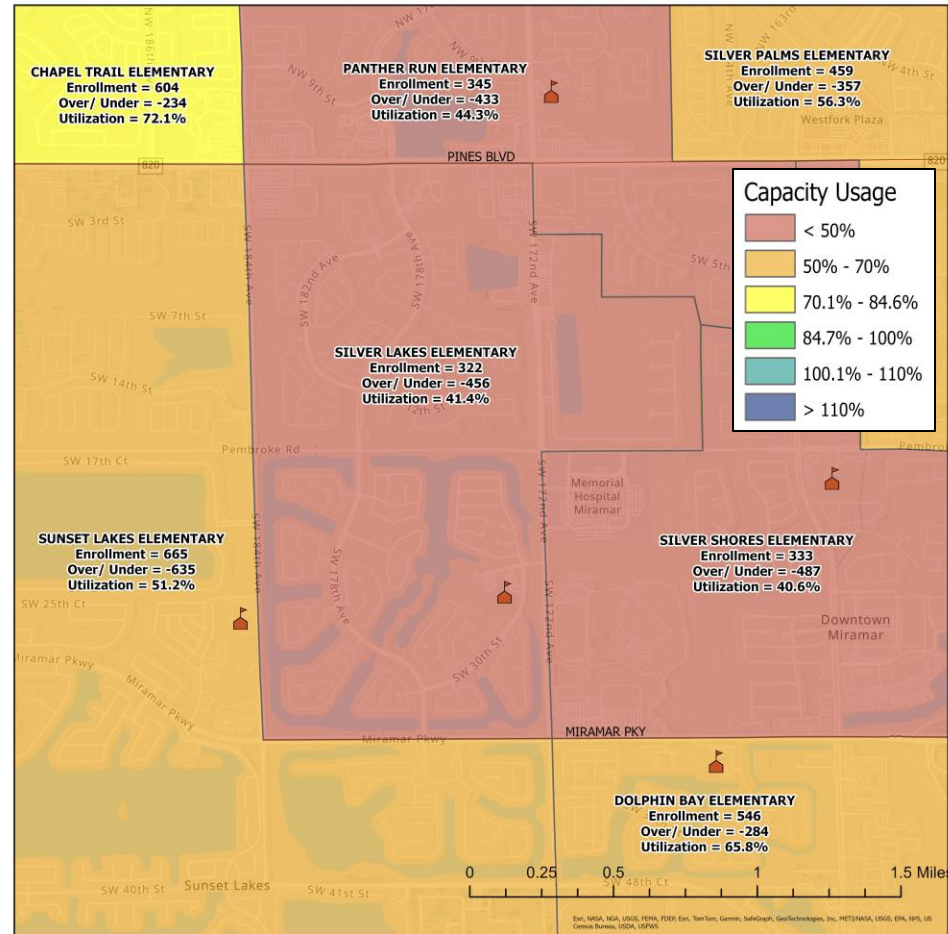
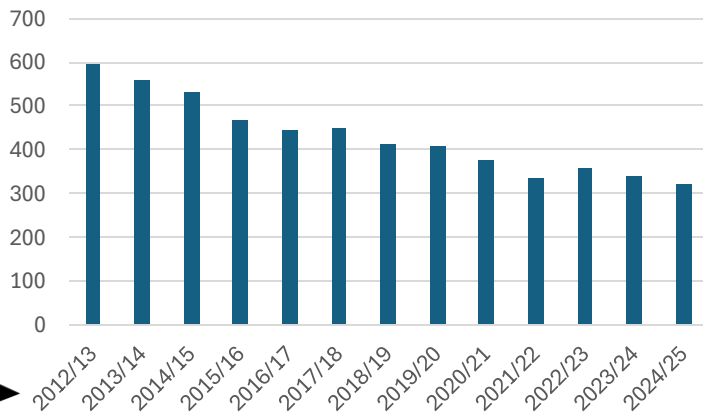
Silver Shores ES Enrollment 2012/13 - 2024/25



Silver Lakes Elementary Enrollment and Capacity Usage

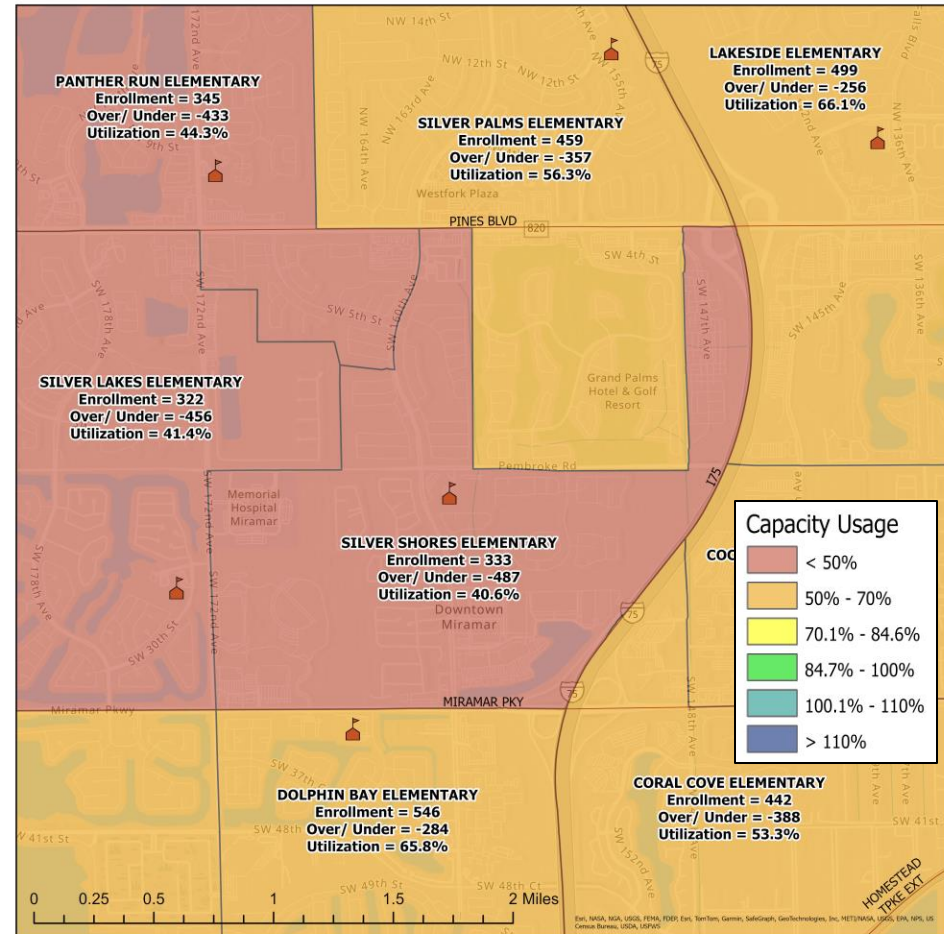
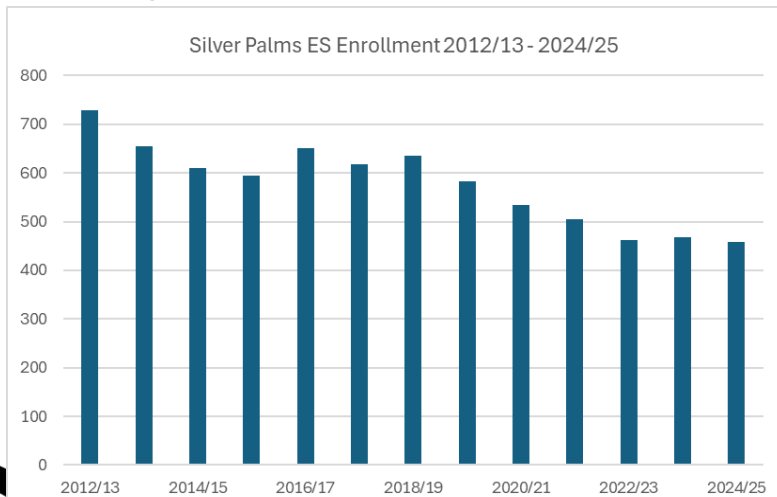

Silver Palms Elementary Enrollment and Capacity Usage

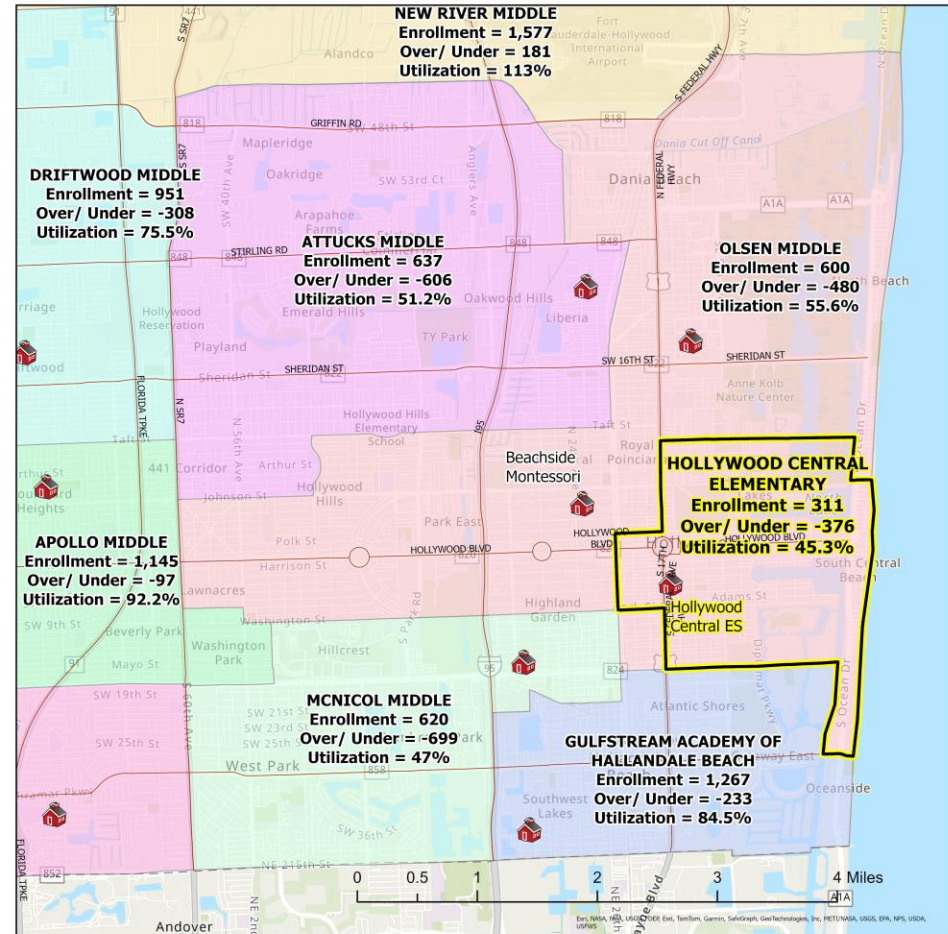
- Total Students Living In Boundary = 764

Silver Shores/ Silver Lakes/ Silver Palms Boundary Considerations

Consideration	
Impact on Enrollment	Silver Lakes current enrollment: 322 students/ 41.4% usage; as a result of the proposal: 449 students/ 57.7% usage Silver Palms current enrollment: 459 students/ 56.3% usage; as a result of the proposal: 506 students/ 62.0% usage
Impact on Feeder Patterns	Fixes current split Silver Shores feeder pattern by assigning portion north of Pembroke Road to Silver Palms which feeds to Walter C. Young Middle/ Charles W. Flanagan High
Impact on Neighborhood Integrity	Does not split any neighborhoods
Impact on Distance to School	Some students who can currently walk to Silver Shores will need a bus to Silver Lakes
Impact on School Diversity	Silver Shores: White 46.5%, Black 41.1%, Hispanic 51.2%, FRL 87.7% Silver Lakes: White 50.6%, Black 39.8%, Hispanic 7.7%, FRL 87.3% Silver Palms: White 60.1%, Black 27.5%, Hispanic 50.1%, FRL 48.4%
Impact on Students with Special Needs	Silver Shores: 143 ESE students/ 12 ESE special programs Silver Lakes: 118 ESE students/ 7 ESE special programs Silver Palms: 113 ESE students/ 4 ESE special programs

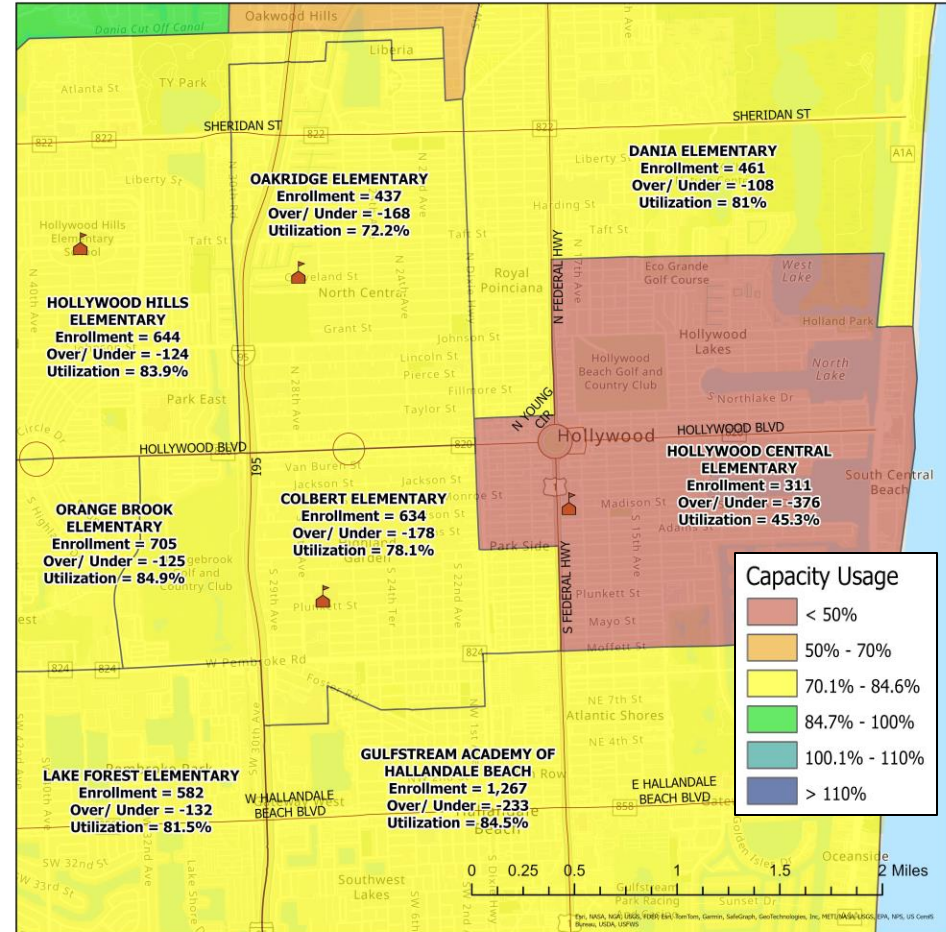
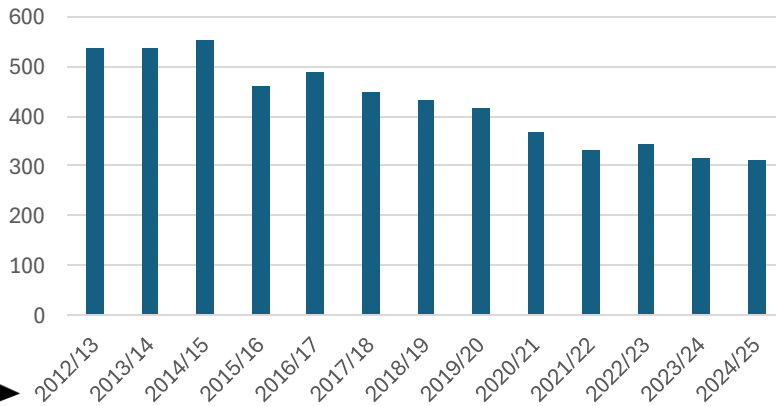
- Reconfigure Hollywood Central Elementary as a K-8 school
- Currently 320 6th-8th grade public school (BCPS + charter) students living in Hollywood Central ES boundary
 - 84 (26.3%) attend Olsen Middle
 - 166 (51.9%) attend charter schools

- Total Students Living In Boundary = 793
- In-Boundary Students Attending = 241
- Percent of Assigned Students Attending = 30.4%
- Out-of-Boundary Students = 70
- ESE Classes = 4
- Prekindergarten Classes = 0

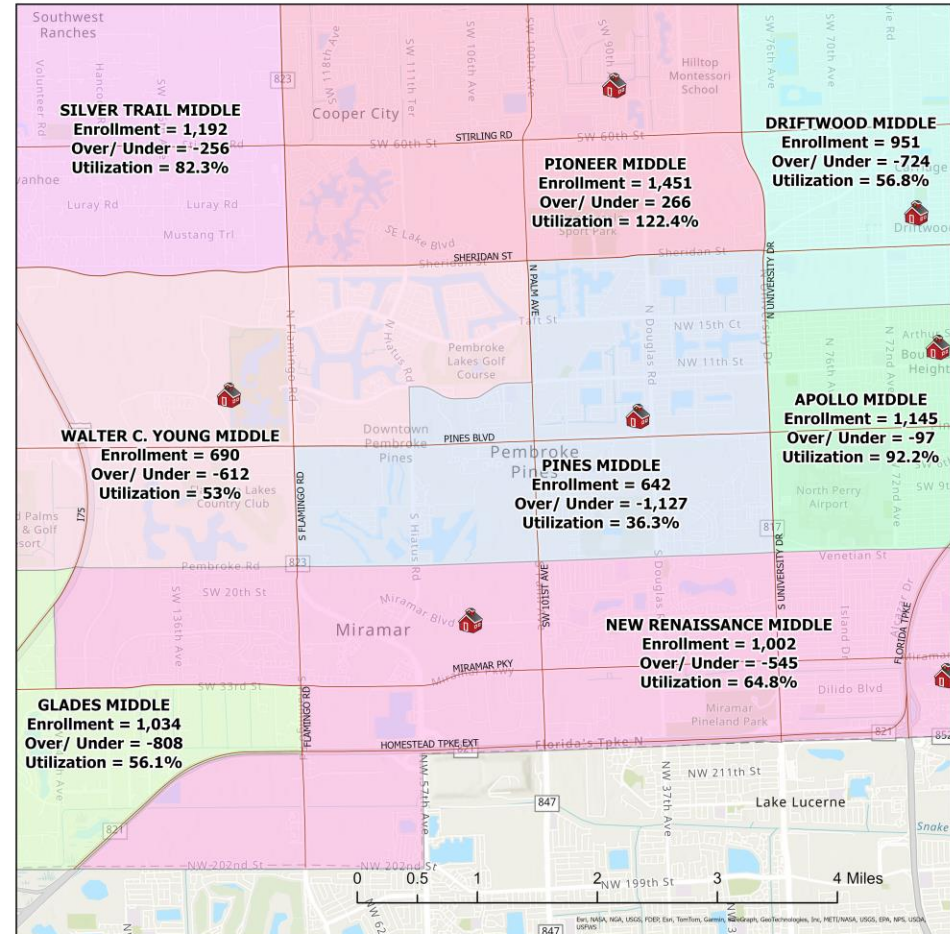

Impact on Neighborhood Integrity	Improves neighborhood integrity by allowing students to remain in their community from PreK through 8 th grade
Impact on Distance to School	Improves distance to school for 6 th – 8 th grade students who currently have to travel to Olsen Middle
Impact on School Diversity	Is not anticipated to impact diversity as 6 th - 8 th grade students will matriculate from elementary grades at Hollywood Central Elementary
Impact on Students with Special Needs	Hollywood Central Elementary: 76 ESE students/ 4 ESE special programs

Pines Middle Potential 6-12 Reconfiguration

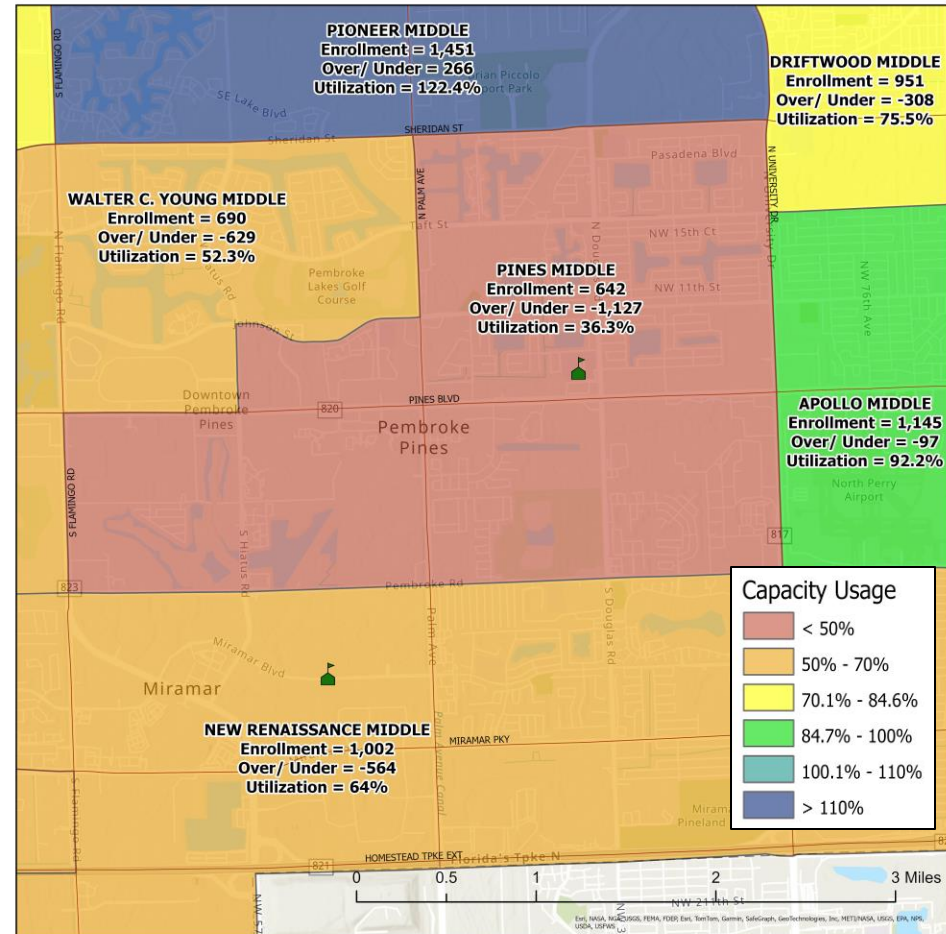
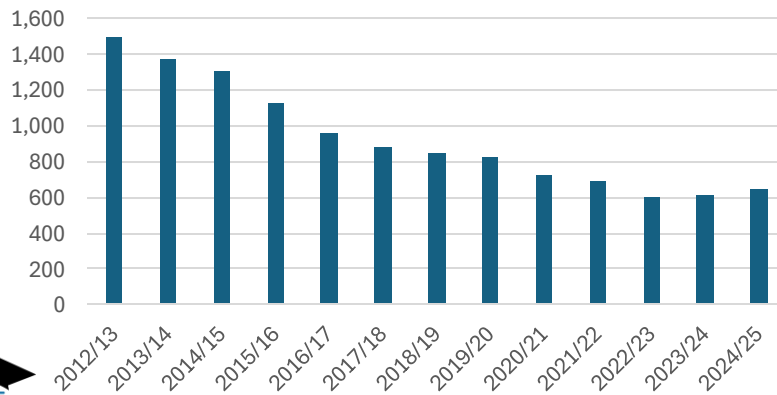
- Reconfigure Pines Middle as a 6th – 12th grade Collegiate Academy
- Currently 2,204 9th-12th grade public school (BCPS + charter) students living in Pines Middle boundary
 - 976 (44.2%) attend Charles W. Flanagan High
 - 188 (8.5%) attend McArthur High
 - 634 (28.8%) attend charter schools



Pines Middle Enrollment and Capacity Usage

- Total Students Living In Boundary = 1,565
- In-Boundary Students Attending = 459
- Percent of Assigned Students Attending = 29.3%
- Out-of-Boundary Students = 183
- ESE Classes = 1
- Prekindergarten Classes = 0

Impact on Enrollment	Pines Middle current enrollment= 642 students/ 36.3% capacity usage; proposal would result increase enrollment by adding four grade levels
Impact on Feeder Patterns	No impact; high school enrollment is a choice option
Impact on Neighborhood Integrity	No impact on neighborhood integrity
Impact on Distance to School	Improves distance to school for 9 th – 12 th grade students who live close to Pines Middle but further from assigned high schools
Impact on School Diversity	Is not anticipated to impact diversity as 9 th – 12 th grade students will matriculate from middle school grades at Pines Middle
Impact on Students with Special Needs	Pines Middle: 106 ESE students/ 1 ESE special program

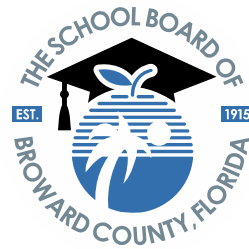
