Remove dented can/provide intact canned food without dents on hermetic seal. Items removed.</p> <p>CODE REFERENCE: 64E-11.003(1). The food packaging shall not be compromised nor the true appearance, color, or quality of a food be intentionally altered.</p>
<p>Violation #47. Food &amp; non-food contact surfaces Ice buildup in milk cooler. Repair refrigerator to stop ice buildup.</p> <p>CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
<p>Violation #54. Garbage &amp; refuse disposal Area under somat dumpster observed with accumulation of debris and paper pulp. Maintain garbage area clean.</p> <p>CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.</p>
<p>Violation #55. Facilities installed, maintained, &amp; clean Ceiling tile not properly placed on railing above prep-sink. Place ceiling tile correctly to avoid open access. A/C vent not securely attached to ceiling by employee lounge entrance. Securely attached A/C vent.</p> <p>CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
