- VII. **Adjournment** – Mr. Myers ended the meeting at 9:21am.



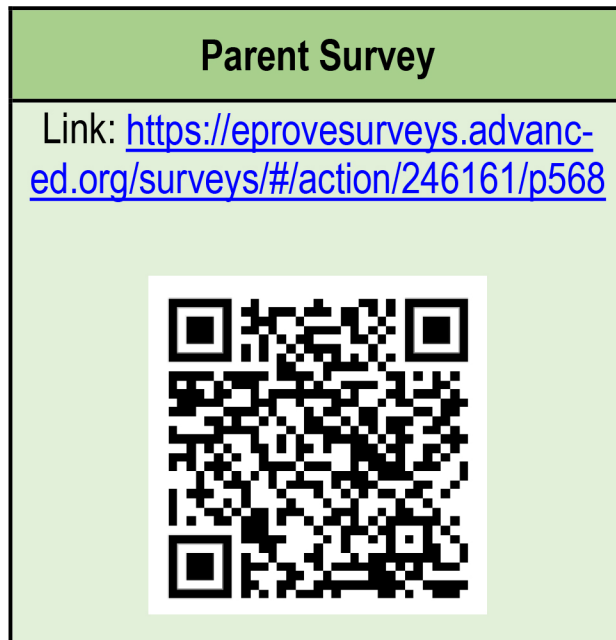




