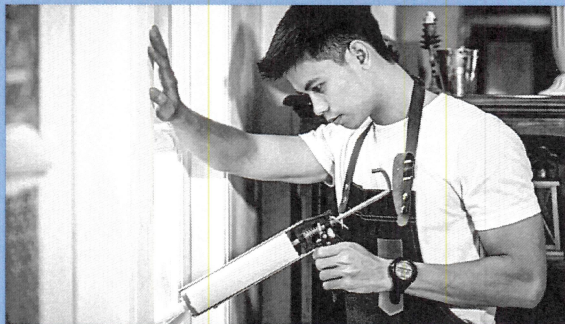
# HOME REHABILITATION PROGRAM

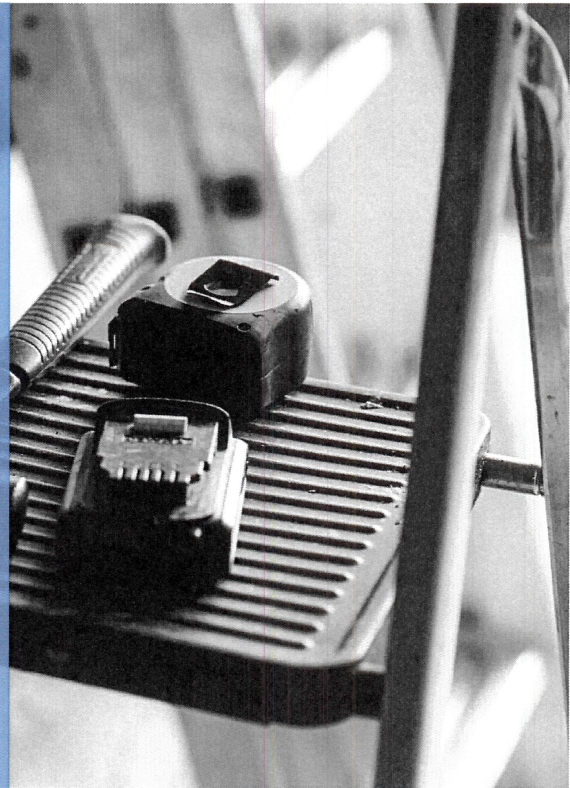

# CITY OF DEERFIELD BEACH RENTAL & UTILITIES ASSISTANCE PROGRAM

## DO YOU NEED HELP WITH RENT AND UTILITIES?

The City of Deerfield Beach COVID-19 Temporary Rental and Utility Assistance Program provides emergency assistance to families financially impacted by the COVID-19 pandemic. The program provides payment assistance for renters behind on rent and/or utilities. Assistance will be provided for up to 6 months and will not exceed \$10,000 including utilities allowance of up to \$1,000.

## ELIGIBILITY CRITERIA

Applicants may qualify for consideration provided they meet all the following criteria.

- Applicant(s) must reside within the city limits of Deerfield Beach
- Household income must be at or below 80% Area Median Income.
- Applicant(s) must have documentable information to evidence loss of income, reduction in hours, or unemployment as a result of the COVID-19 Pandemic; that contributed to missed rent and/or utility payments.
