Through our various parent/guardian meetings and our SAC, SAF, and Title 1 Events we encourage parent input as we make decisions to positively impact Nova Eisenhower. Parents/guardians are made aware of Title 1 Allocation of funds, how there are being utilized, and how it is imperative to have their input while making decisions that will impact their children. Also, an annual Title 1 Survey evaluation is conducted to adhere to the needs of all stakeholders. The results are used to evaluate the effectiveness of our Parent and Family Engagement initiative.*

Additionally, the NEE News Newsletter will have a Title 1 section which will focus on news, events, and updates.*


