Congratulations to Randa Flinn at **Northeast High School** for being one of 51 state winners in the **Samsung "Solve for Tomorrow" Contest**, a nationwide competition to raise enthusiasm for science, technology, engineering and math (STEM) by challenging students and teachers to tackle critical community issues across the country. Northeast High School will receive **\$20,000**

worth of Samsung equipment for student use, as they prepare for the next round of the yearlong competition. GAGP staff are proud to have been able to identify this grant opportunity and encourage and support Ms. Flinn during the application process.

Broward County Public Schools is honored to be the recipient of a \$1.2 million grant from the National Science Foundation to develop a model for science, technology, engineering and math (STEM) and computer science in elementary schools. The project will create hands-on learning applications for students through a "STEM plus computing curriculum," allowing students to build models and prototypes to improve problem solving skills and develop their critical thinking abilities. The District will also work with teachers to develop STEM problem-based learning and teacher professional development materials, to address



challenging new areas for young learners. GAGP provided support to Lisa V. Milenkovic from the Math, Science, and Gifted Department to submit the proposal, manage legal contract routing, coordinate board approval, and press release development with the Public information Office.



NAMM Foundation grants support organizations that expand access and opportunity to music education for thousands of individuals and provide innovative music education and hands-on music making programs. NAMM has awarded Bethune, Lake Forest and Walker grants of **\$8,000** each to support teacher professional development in arts integration and

access to instruments. GAGP worked with District Turnaround Arts staff and teachers to conduct music program needs assessments, identify priorities and write the proposals.



Turnaround Arts schools received special recognition at the December 8, 2015 regular school board meeting. The Turnaround Arts initiative includes three elementary schools in Broward County Public Schools (BCPS) – Bethune Elementary School, Lake Forest Elementary School, and Walker Elementary School – in an effort to narrow the achievement gap and increase student engagement through the arts.

BCPS is one of five school districts in the nation, and the only school district in Florida, selected to partner with Turnaround Arts. The selected schools will receive arts education

training and resources to address their individual needs. Resources include a summer leadership program, in-school professional development, partnerships with community arts education, and cultural organizations, art supplies, and musical instruments.



Nova Eisenhower Elementary School was recognized for a special award from the national non-profit organization, Code.org. It was the Florida winner of a \$10,000 prize recognizing the school's commitment to having all students participate in Hour of Code activities during National Computer Science Education Week, December 7-13, 2015.



Representatives from the **W.K. Kellogg Foundation** and a group of community partners visited Dillard Elementary School on January 28, 2016 to discuss the progress related to the generous grant that will provide a multi-year program for early learning instruction, parent engagement and administrative leadership, within early childhood programs and participating elementary schools. In 2015, Broward County Public Schools (BCPS) Minority Success Academy Early Years Program was selected for **\$200,000** grant from the W.K. Kellogg Foundation. The grant will help connect and align early childhood providers with seven BCPS elementary schools – Broward Estates Elementary School, Dillard Elementary School, Dr. Martin Luther King, Jr. Montessori Academy, Thurgood Marshall Elementary School, Rock Island Elementary School, Sunland Park Academy and Westwood Heights Elementary School.









During a kickoff event held on January 28, 2016 at Lauderdale Manors Early Learning and Family Resource Center Multi-Purpose/Cafeteria, the *PNC Foundation* announced its Grow Up Great grant award to Broward County Public Schools (BCPS) for more than \$56,000. Sesame Street's Elmo joined the festivities, with a surprise visit to pre-kindergarten students participating in the event.

The PNC Grow Up Great grant supports Science, Technology, Engineering, Arts and Math (STEAM) initiatives, which enhance preschool education. BCPS will work with fellow grant recipients Palm Beach State College and the Young at Art Museum (Broward) to improve access to arts and science resources for hundreds of pre-K students, their families and early childhood educators. The Broward Education Foundation is also partnering with BCPS to support the Grow Up Great grant.

BCPS GRANT spotlight

Broward College has approved \$20,000 in grants to support student-run community development work at Dillard, Plantation, and South Broward High Schools. The Woodlawn Cemetery Historic Preservation project at Plantation High School allows students the opportunity to learn local history while contributing to the preservation of one of the oldest cemeteries in South Florida. The student's preservation efforts will focus on clearing debris from the cemetery plots and cleaning the headstones and man

This grant opportunity was disseminated to all schools through the Grants Conference, group email to all Principals, and notifications through PIVOT and Principal Memo finder. GAGP staff supported the school in developing the application by sharing a previously funded proposal; editing and strengthening the narrative and budget; supporting the development of letters of commitments from community partners including the City of Fort Lauderdale; providing District tax exemption documentation; and preparing the executive summary for the board agenda.

+ Tips of the Day

The 10 Most Common Grant Writing Mistakes

- 1. Not following instructions. This has got to be the biggest mistake, even though it's the easiest one to avoid. Foundations, corporations, and government agencies receive *thousands* of grant proposals, and one way they sort the amateurs from the professionals is to see who followed directions. If the funder requires a three-year budget, create one. If they want you to use paper clips instead of staples, use them.
- 2. Failing to thoroughly research the funders' interests. Each funder has an interest in making grants for a particular purpose—sometimes a very specific purpose. Many grant proposals never have a chance of success because of superficial research. It's not enough to know that the foundation makes grants for education. Do they support K-12? Adult education? Do they specialize in funding organizations working with high poverty schools? The answers to all those questions can be yours by simply reading all of the foundation's guidelines.
- 3. Focusing the proposal on the needs of your organization. Keep in mind that a funder's goals are achieved not when you make payroll, but when you deliver the service your nonprofit provides to the people who need it. So you don't ask for \$10,000 to prevent your food bank from having a deficit; you ask for \$10,000 to feed 7,000 people. Even if you're asking for operating support, be sure to include how your nonprofit will do more for more people by receiving the grant you're requesting.
- **4. Careless editing.** Pity the poor program officer who has to read 600 grant proposals on the same topic. How do you think she'll feel when she has to re-read your sentences because of typos and grammatical errors? Keep her on your side. Spell check and have a friend proof read.
- **5. Preaching to the choir.** Never assume the funder knows anything about your organization, especially when it comes to describing your capacity to carry out the project for which you seek funding. And while you're at it, avoid catch phrases and jargon. Clear, simple language wins the day.
- **6. Not asking for the money.** You wouldn't believe how many people forget to include the amount of the grant they seek in

the proposal. The people at the foundation aren't mind readers! Be explicit, usually in the first sentence or two about how much you would like for them to give you.

- 7. Asking for the wrong amount. This mistake is closely related to number 2. In your research, you should determine what size grants the funder has made to similar organizations. When you look at their grants list, you'll see that most funders have a number they seem fond of. Asking for substantially less or more than their typical grant will end in failure.
- 8. Submitting sloppy budgets. You may be familiar with three or four budgets for programs like the one for which you're seeking funding, but the program officer at the funder has seen hundreds if not thousands of similar budgets. She will know immediately if your budget is reasonable for your project. If you've left out a major item, she'll know. If you've padded the salaries, she'll know. The budget that accompanies a grant proposal should be prepared with the same care as the narrative description and match it point for point.
- **9. Submitting a proposal late.** This is absolutely the most amateurish and easily avoided mistake, yet it happens all the time.
- 10. Not asking for a grant. There never is a perfect time to ask for a grant. The economy is down. You're too busy to finish the proposal by the deadline. You worry the funder has never heard of you. Excuses are easy to come by, but you'll never get a grant if you don't try. So what are you waiting for? Start researching and writing now!
