Mrs. Flournoy reviewed the SESIR data. We had 8 incidents. However 7 out of the 8 were transient.

Presentation:

- Overview of A plus funds - \$166,352.00
Mrs. Mills reviewed the Timeline and steps that we as a school take in order to establish the proposals for the Florida School Recognition Dollars. 1st the state releases the money to the schools. Then the SAC generates and approves the proposals. After that, all faculty and staff and vote by secret ballot. The proposal must pass with majority (51%). We then reviewed what the money can be used for.
- Establish Quorum
We verified that we have quorum so that we could generate and vote on the proposals.
- Brainstorm and Generate Proposals
Mrs. Mills shared what we have proposed in the past, to distribute the funds equally amongst the whole faculty and staff who were employed at least 99 days of the previous year and are in good standing (not under SIU investigation). Mr. Schroeder shared that while we have used Title 1 funds in the past to fund our Tutoring camps, the state has not released those funds yet. We may get up to \$9,000 . He also shared that we have used \$30,000 last year to fund the camps. We did start the camps earlier and extended it to our K-5th grade students.

So it was suggested that we use \$20,000 of the funds to go to the tutoring camps and the rest of the money to be distributed equally amongst the staff of the 2021/2022 school year. We voted unanimously that should be the 1st option. The motion was approved by Khadijah Muhammad and second by Mrs. Schwab.

Then we proposed that we use all of the money to be distributed to the teachers equally. The motion was approved by Mrs. Garvin Gibson and second by Mrs. Roberts. Parents questioned if the money could be used for enrichment and remediation. The proposal was revised and was voted for unaminously.

The last recommendation was to decrease the amount for camps to \$15,000 and add \$1,000 to go towards materials and supplies. The proposal was voted for
