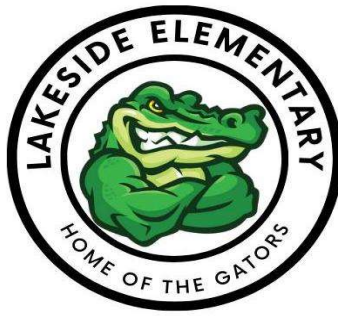

Dr. Rodriguez mentioned we took the lowest quartile to help them move. He mentioned the school has been struggling with the lowest quartile. He mentioned Ms. Leal and he are both evaluated based on goals. There will be a total of three goals they are evaluated on and it will probably be ELA, Math and Science.

- a. Dr. Rodriguez explained how free and reduced lunch affects the goals, resources, and budget. He mentioned class size was funded incorrectly and it does not fund the teacher, therefore class sizes will increase. He stated, "We will make it work."

1) Update on Transportation

- Currently transporting 60,000 students a day
 - There is a shortage of drivers, 92 vacancies. Hiring push.
 - o Pay rate \$18/hr, \$1,000 signing bonus.
 - o Buses run from 4am-8pm, typical routes run from 5:30am-5:30pm
 - o Drivers guaranteed 7 ½ hour work day part time, full time 12 hours per day
 - Shortage is a national issue, there are stories from other parts of the country where National Guard has been called in to drive buses.
 - Many initiatives taken to improve service:
 - o Beginning in September 2023, “Here Comes the Bus” app which provides real time locations of bus
 - o Register to Ride has allowed more efficient routing of students, helped avoid resources being wasted on students who do not ride the bus
 - o Since COVID-time, 995 routes have been reduced to 275 to mitigate driver shortage. Relates to the process by which school districts and schools identify, assess, manage, and monitor potential and real threats to student safety - Driver Appreciation Week is next week - Website for more information: browardschools.com/transportation

 - Alan Strauss is the regional superintendent
 - Khandia Pinkney is the Assistant Director (handles calls/inquiries to their office)
