He was asked about ARP funding to accommodate those schools, particularly across the whole district when it comes to specific items. I believe somebody saying \$96 million and that's not something that I have information about. I think that's the total value of the Lenovo or the devices and computer bids. The total contract price. Today we maintain a 2.5:1 ratio. The board did not decide to make it a 1:1 ratio. Some of the money went to new computer carts, wiring of the carts, power adapters, management tools for inventory, wireless access points which totaled \$37 million. We have an accounting of what we deliver to every different school.
