

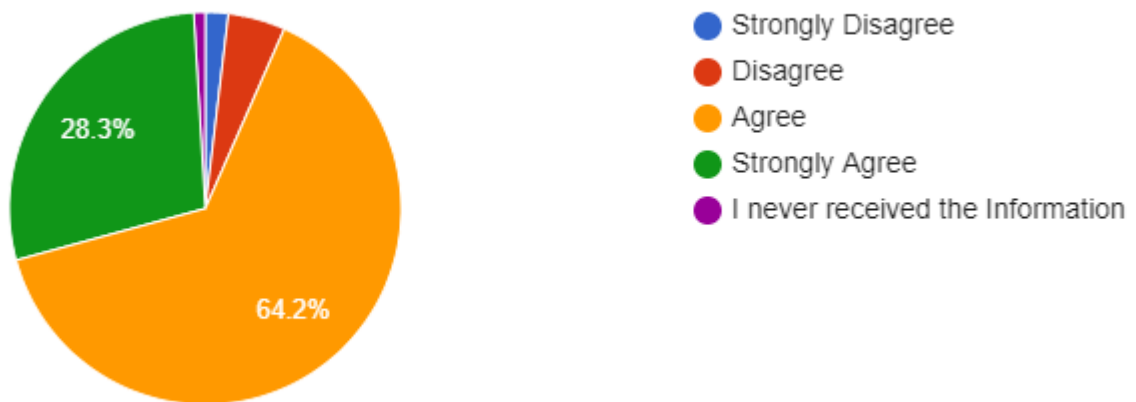

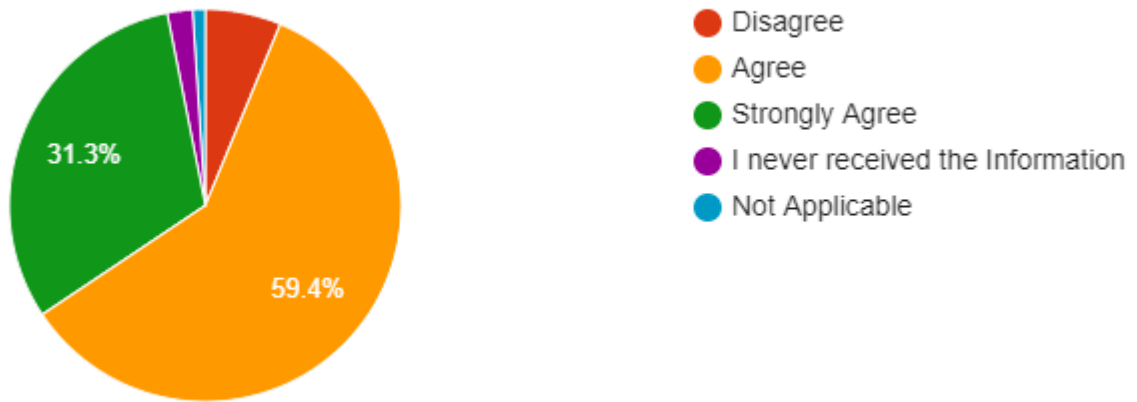
1. I often receive information from my child’s school about what the school teaches my child.

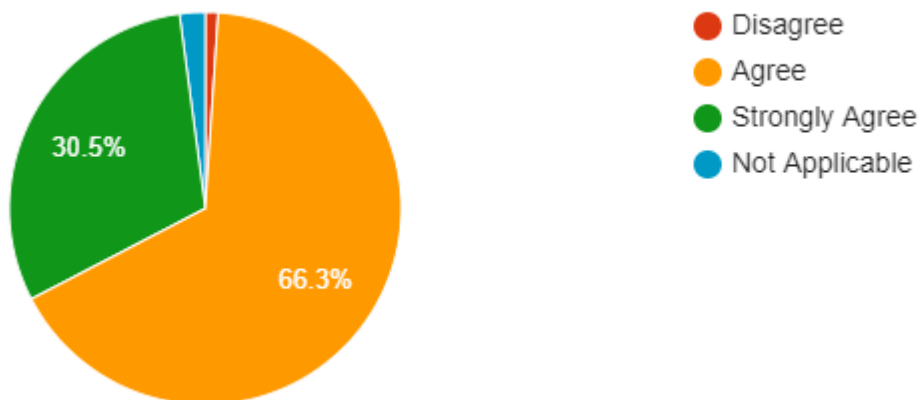

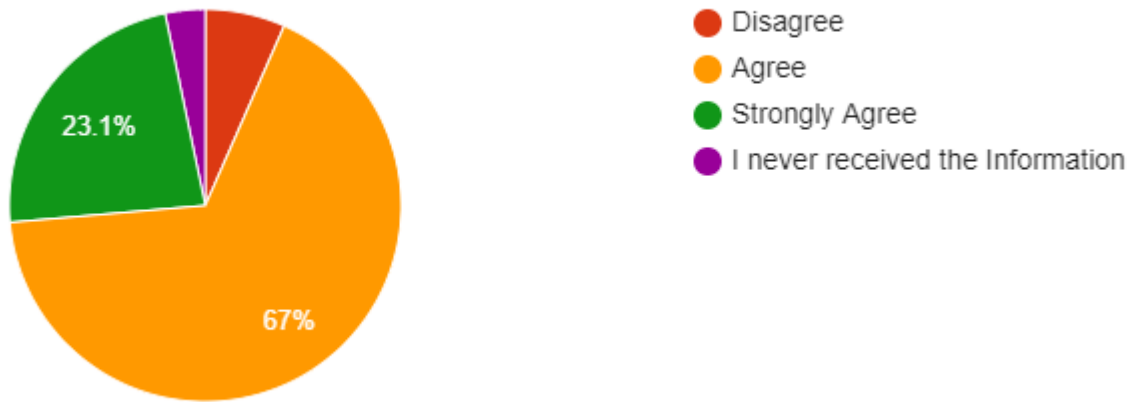

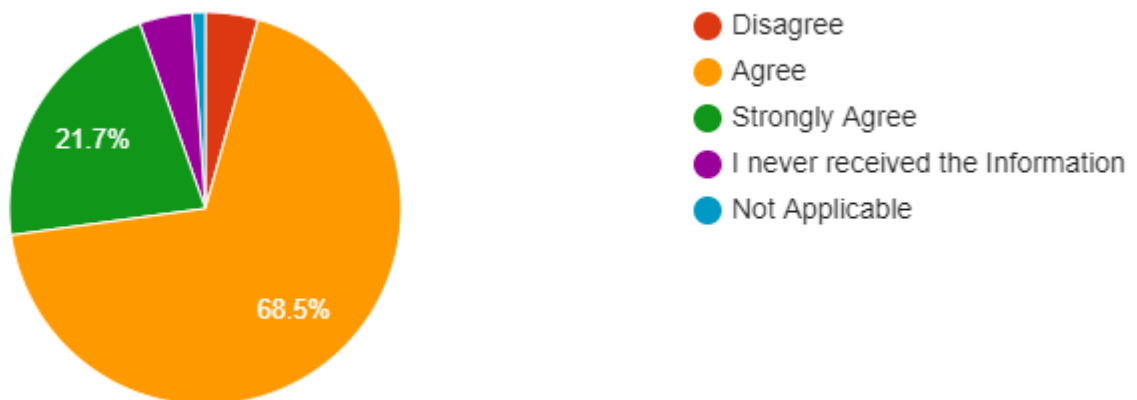

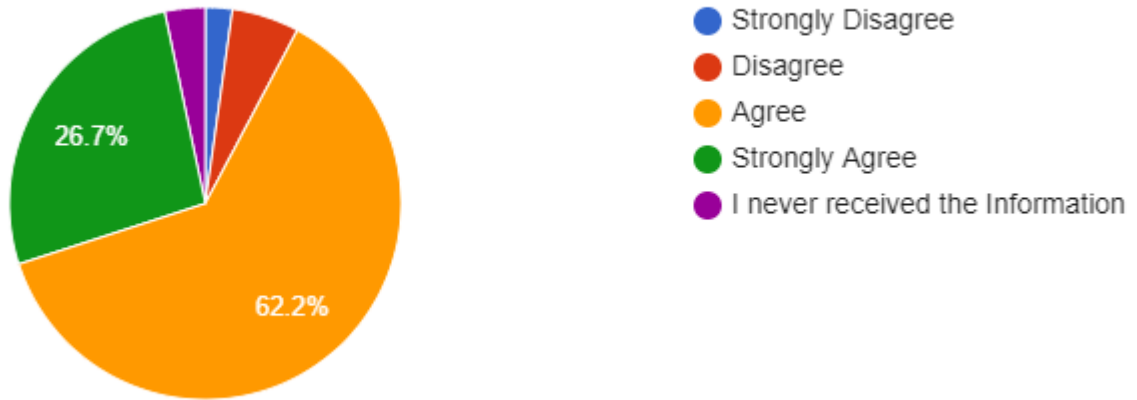

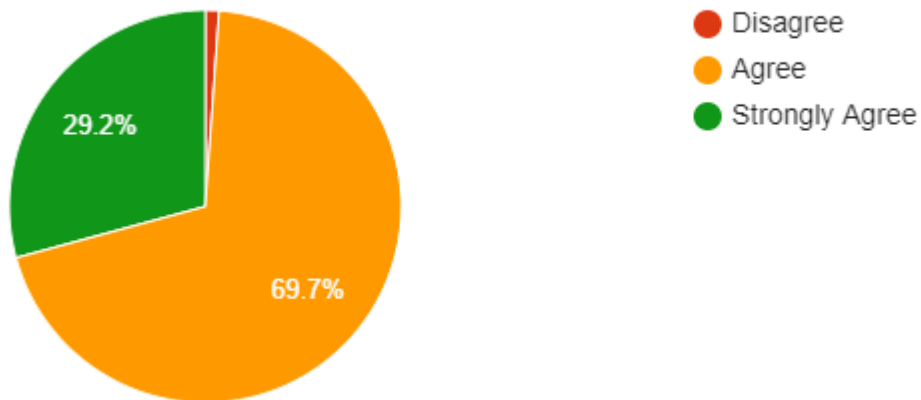

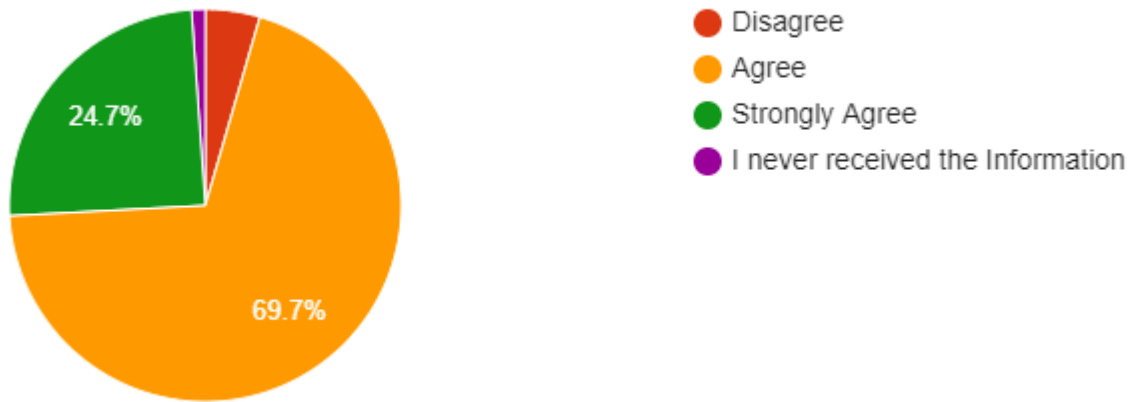

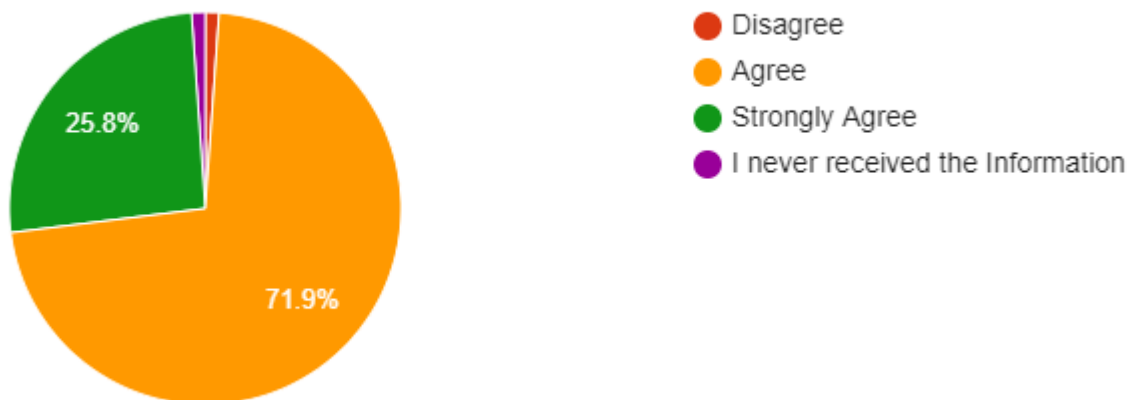

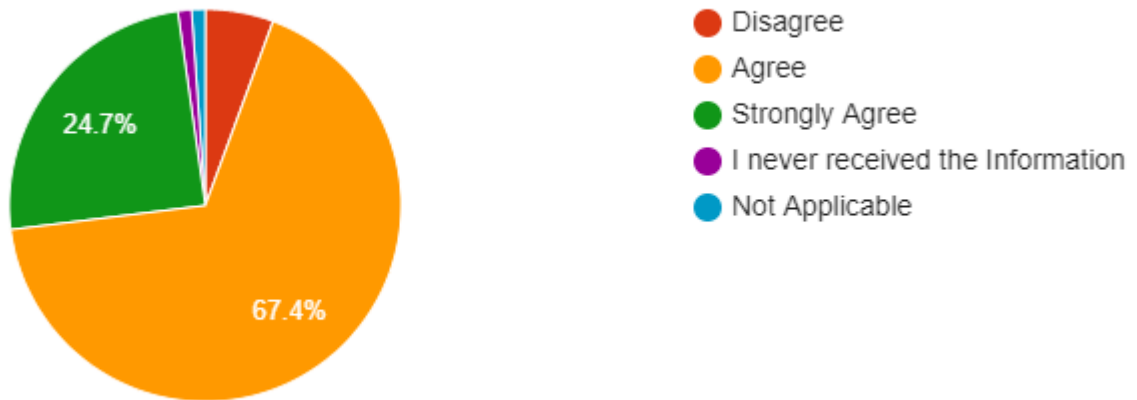

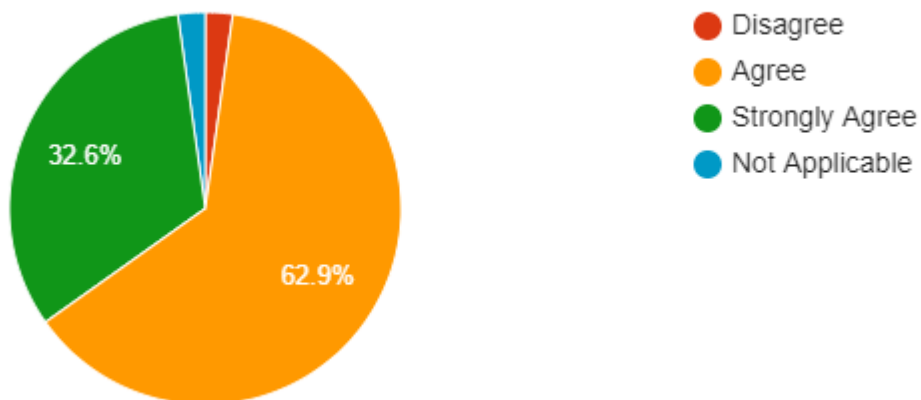

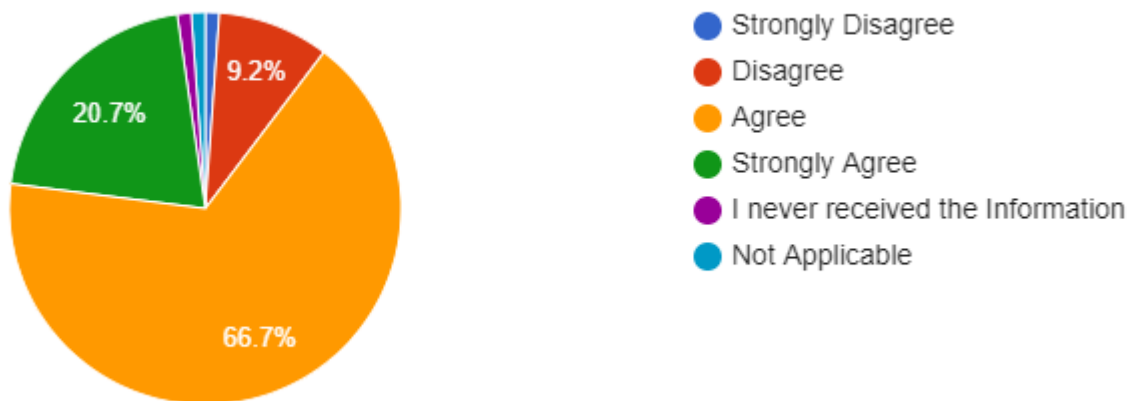

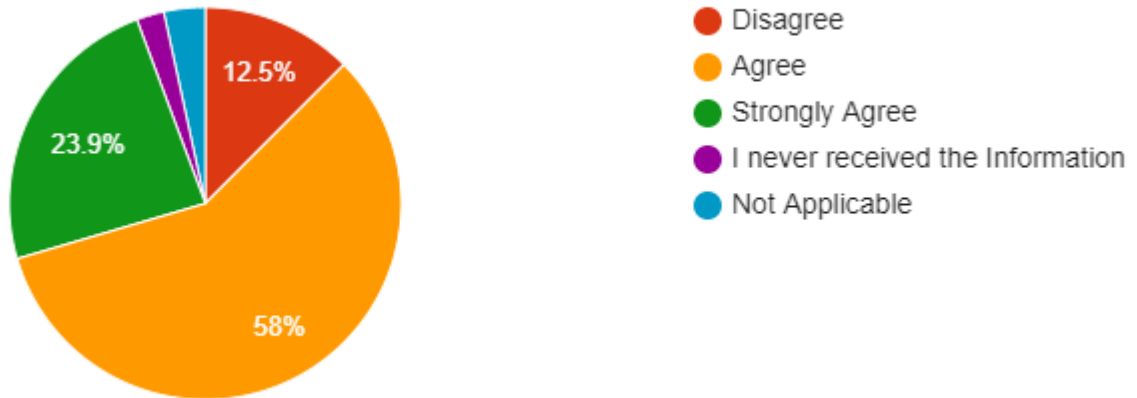

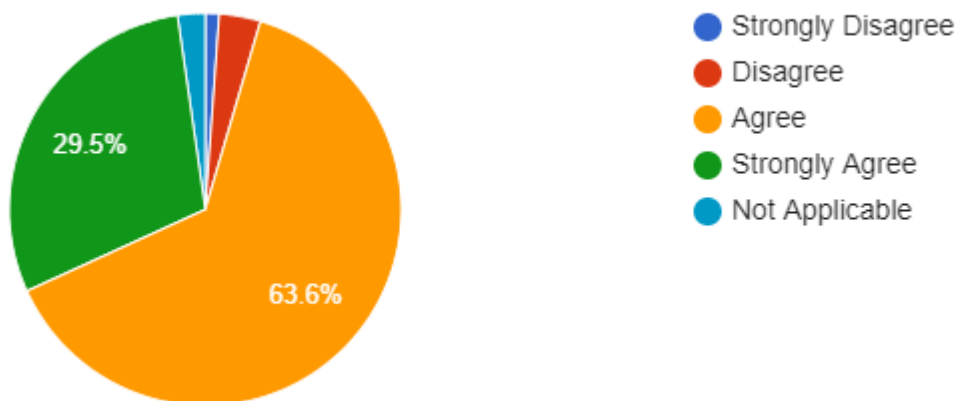

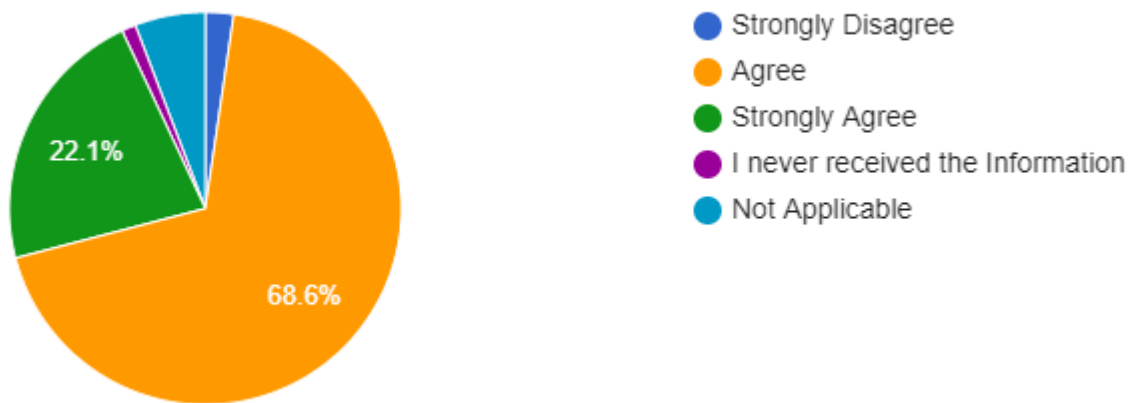

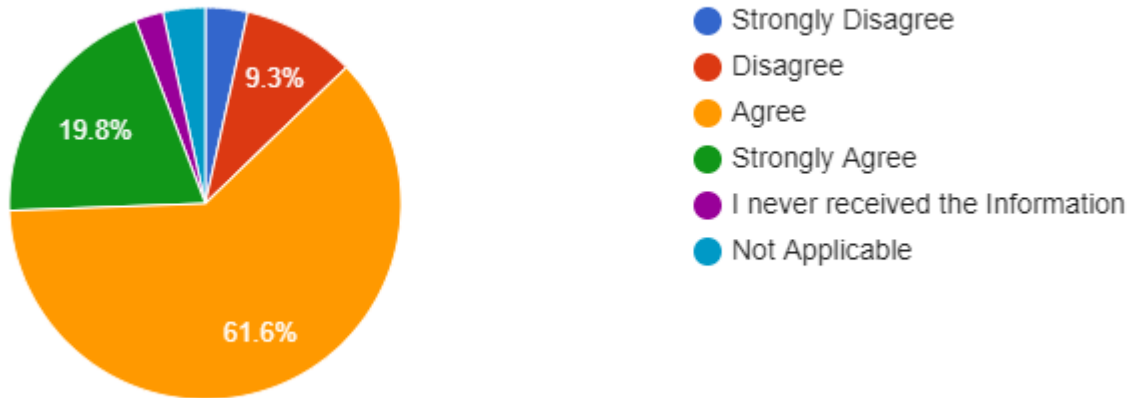

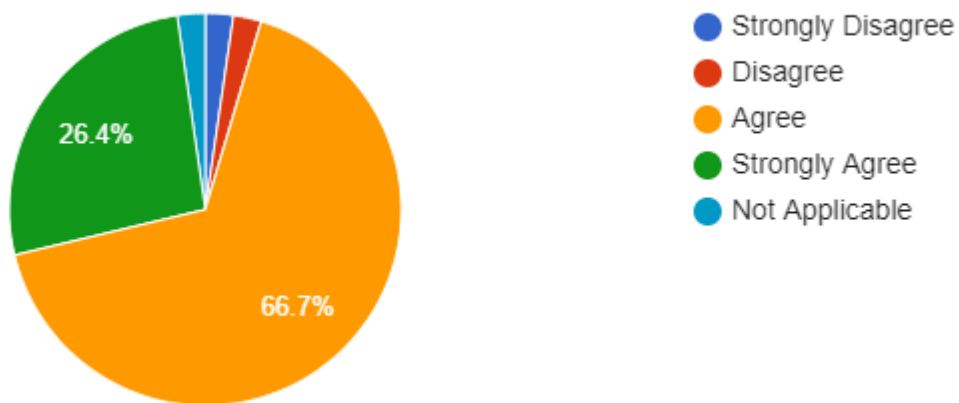

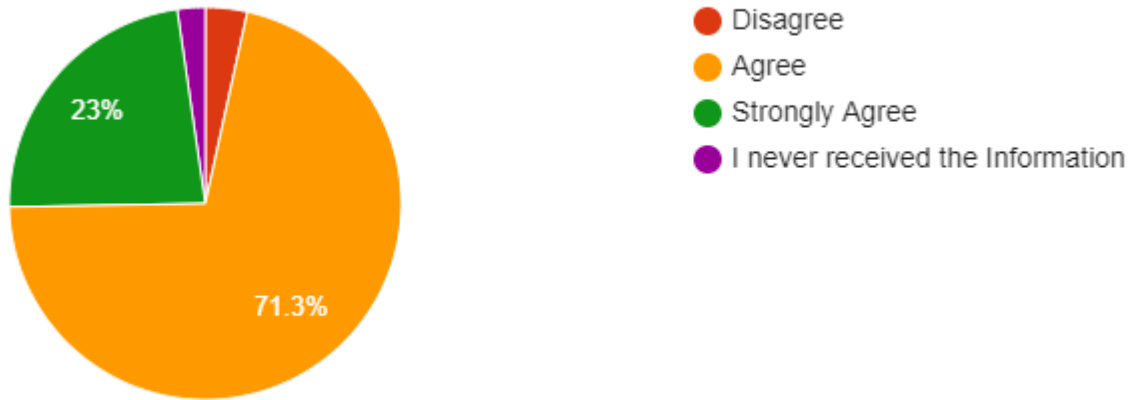

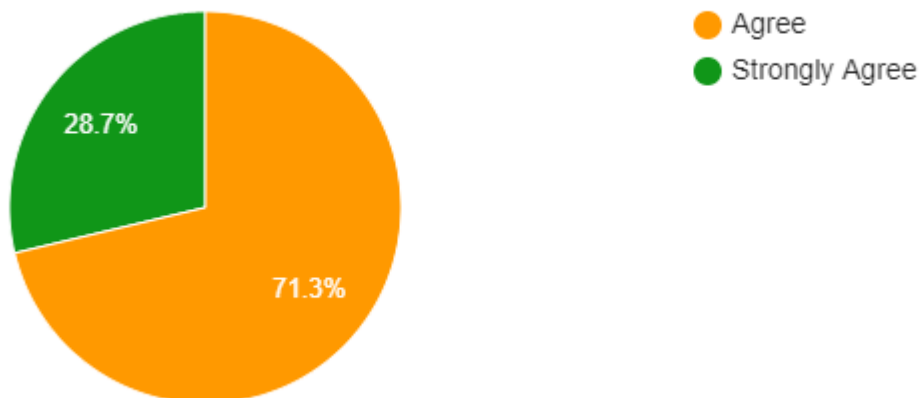

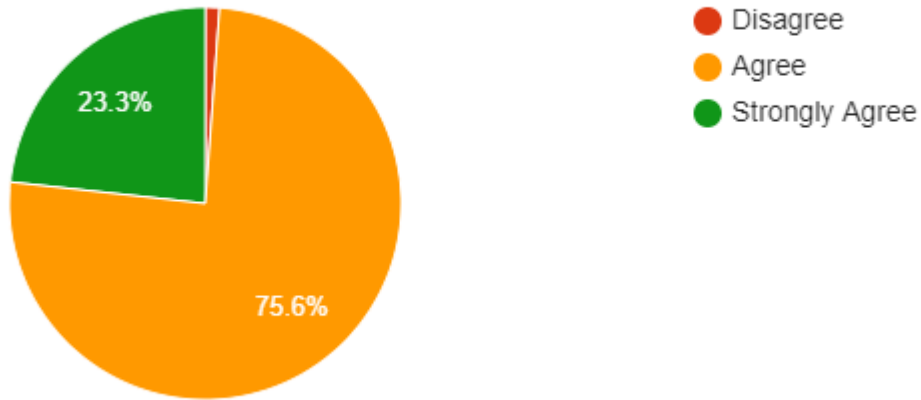

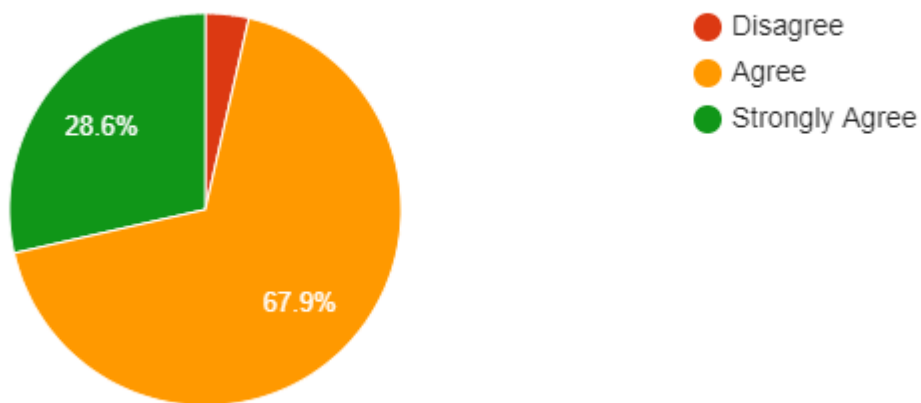

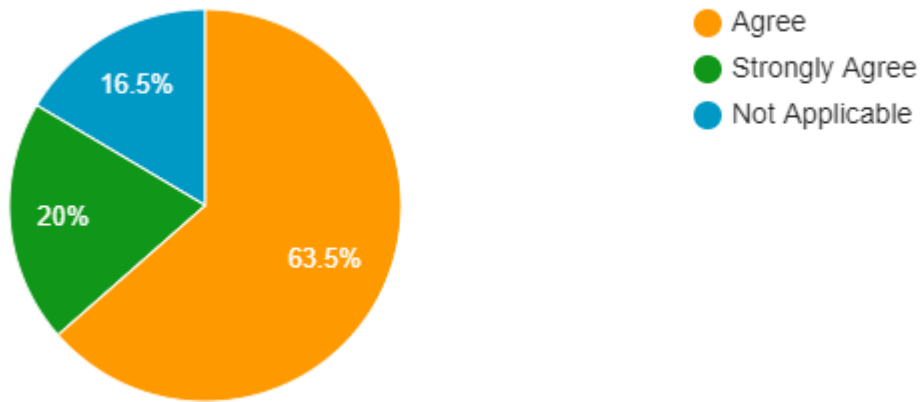

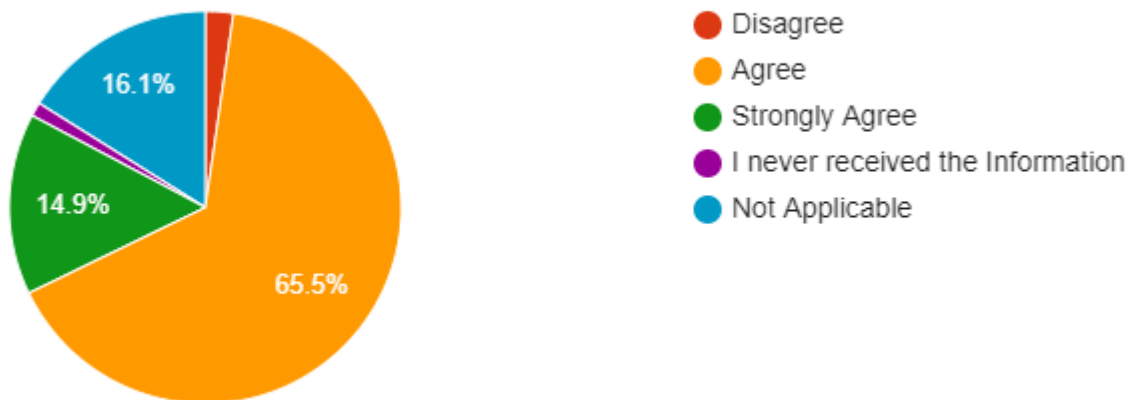

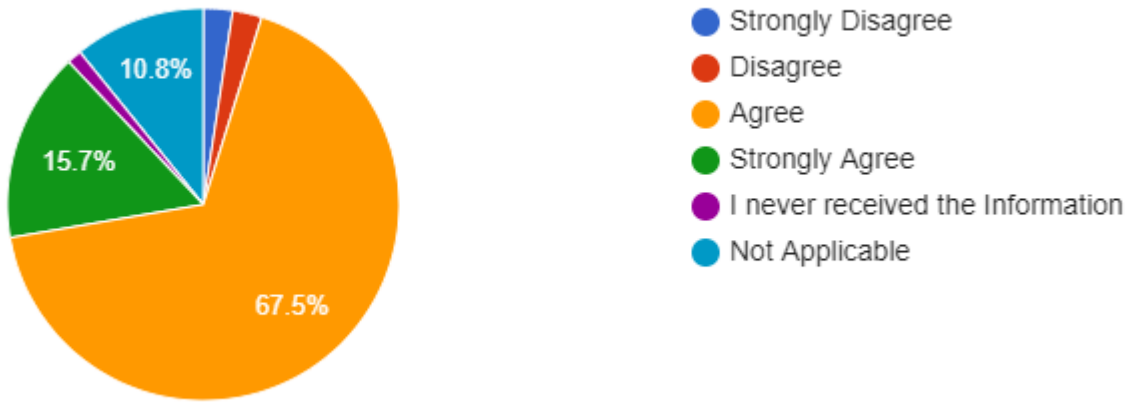

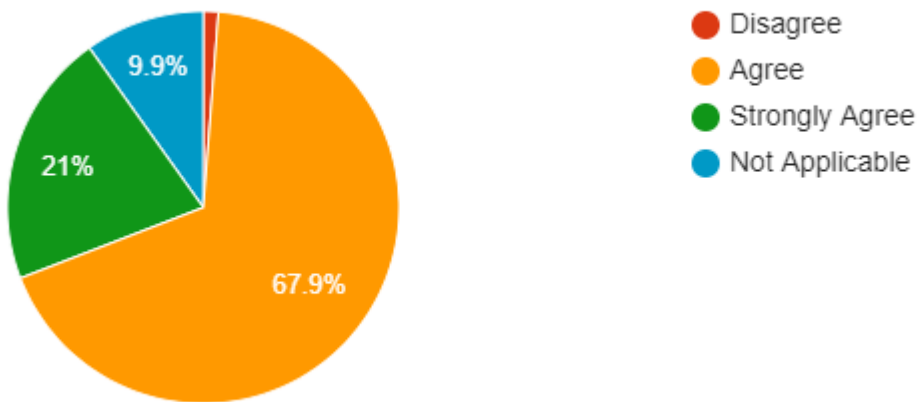

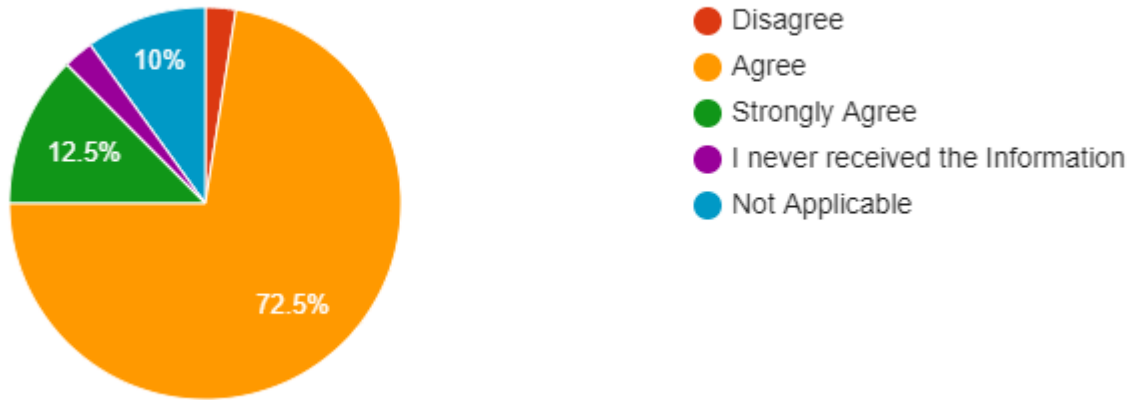

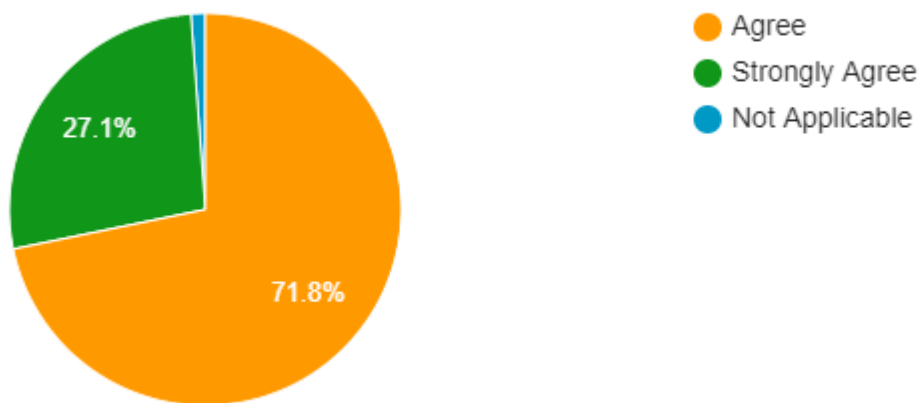

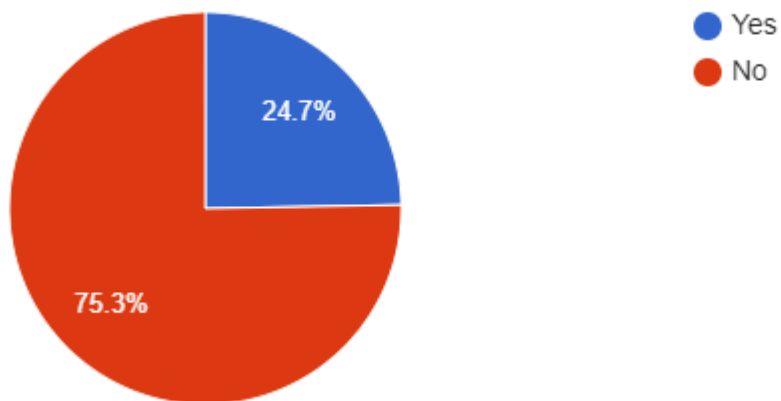

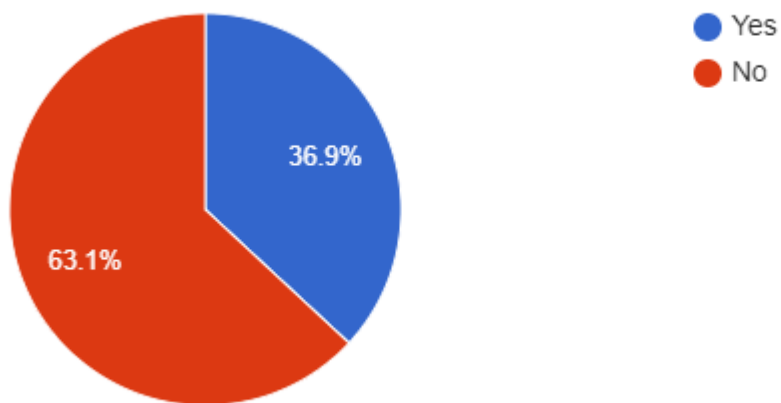

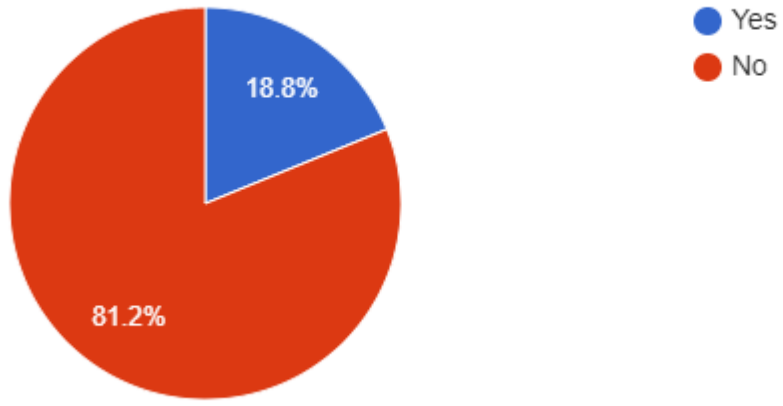
